### DYNAMIC NEW PROGRAM OFFERS STUDENTS A CLEAR PATH TO ONE OF THE WORLD'S FASTEST GROWING PROFESSIONS -HEALTHCARE MANAGEMENT



Allegheny College has unveiled two exciting new degree programs beginning this fall: a Bachelor of Science and an accelerated Master of Science in Healthcare Management.

The BS follows a traditional 4-year undergraduate curriculum, while the Master's program offers students the opportunity to earn both BS and MS degrees in 4 or 5 years. Both pathways benefit from Allegheny's rigorous coursework and unique interdisciplinary and applied approach to learning.

Healthcare Management involves the study of the healthcare industry, including service providers, health economics and financing, insurers, manufacturers, non-profit organizations, and government entities at all levels. It emphasizes an understanding of the complexities of the US healthcare system in the 21st century, including the organization and delivery of preventive health and healthcare services. It also develops the interpersonal, leadership, and management skills needed by healthcare administrators to efficiently and effectively meet health and institutional goals.

Steven Farrelly-Jackson, Ph.D., HCM Program Director commented, "These programs develop students' broader understanding of the pressing challenges posed by soaring costs of US healthcare, inequities of access, and worsening health outcomes – especially for the marginalized and vulnerable. The aim is to train a new generation of healthcare managers who, whatever their role in the healthcare industry, will contribute meaningfully to improved effectiveness, sustainability, and social justice."

Allegheny's Healthcare Management programs draw on the college's proven strengths in its Business and Economics department and landmark Global Health Studies program, as well as decades of success preparing students for healthcare professions. Both BS and MS programs emphasize thorough grounding in economics and business management skills, while also including coursework in medicine, public health, the US health system, the social determinants of health, data analytics, human resources, finance, ethics, and sustainability to ensure that graduates are immediately ready to succeed in whatever area of healthcare management they choose to pursue.

## UNDERSTANDING THE NATIONAL ECONOMIC OUTLOOK WITH THE CLEVELAND FEDERAL RESERVE BANK

Russell Mills, Ph.D, Senior Principal and the Senior Regional Officer of the Federal Reserve Bank of Cleveland's Pittsburgh Branch visited Allegheny College to present the "National Economic Outlook," a discussion of current national economic indicators and financial issues from the perspective of the Federal Reserve Board of Governors.

The Tillotson Room was filled with students and faculty ready to learn more about how the Cleveland Fed creates their portion of the qualitative research included in the "Beige Book" - a Federal Reserve System publication about current economic conditions across the 12 Federal Reserve Districts. It characterizes regional economic conditions and prospects based on a variety of mostly qualitative information, gathered directly from each District's sources.

As the Pittsburgh Regional Officer representing the Cleveland Fed, Dr. Mills included the regional outlook, citing the positive signs in the economy as well as the demographic challenges facing western Pennsylvania. He wrapped up his presentation by informing students of all of the various career opportunities available for students in the Federal Reserve System.

"It was great to have the opportunity to provide an economic outlook talk, share career opportunities at the Federal Reserve Bank of Cleveland, and interact with students, faculty, and staff at Allegheny College and the Center for Business & Economics," says Mills. "The Center for Business & Economics faculty, fellows, and staff did a wonderful job of organizing the event while the students posed very thought-provoking questions following the outlook talk."

This year, 38 students across 21 teams from six colleges and universities — Allegheny, Carnegie Mellon, Duquesne, Grove City, Geneva, and Westminster — entered into the annual event to compete for \$32,000 in prize money - but only 7 teams took home an award at the finals held at Allegheny College's new Allegheny Lab for Innovation and Creativity (ALIC @ Bessemer) in downtown Meadville.

"It is amazing how Allegheny and other schools in Western PA are increasing their focus on developing skills that businesses are searching for today. This year's Competition showed how students are already applying them at the beginning of their careers!" commented Lance Zingale '77, sponsor of the annual competition.

Byron Rich, Assistant Dean for Academic Innovation, programmed the robot housed at the Bessemer lab to hand out trophies to our 2024 winners.

The Zingale Big Idea Competition focuses on seed-level new business ideas. This contest emulates the experiences seen on the ABC show "Shark Tank," but with a heart. Unlike "Shark Tank," the Zingale Big Idea distinguished panel of judges do more than evaluate business models — they offer constructive feedback, coaching, and encouragement.


