

**SUMMARY ANNUAL REPORT FOR  
ALLEGHENY COLLEGE HEALTH & WELFARE EMPLOYEE BENEFIT PLAN**

This is a summary of the annual report of the Allegheny College Health & Welfare Employee Benefit Plan (Employer Identification Number 25-0965212, Plan Number 503) for the plan year 07/01/2022 through 06/30/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Allegheny College has committed itself to pay certain Medical, Prescription Drug, Short Term Disability and Flexible Spending Account claims incurred under the terms of the plan.

**Insurance Information**

The plan has insurance contracts with United Concordia Insurance Company, Vision Benefits of America, Metropolitan Life Insurance Company, Reliastar Life Insurance Company and Aflac to pay certain Dental, Vision, Life insurance, Long-term disability, AD&D, Stop loss, and Workplace benefits claims incurred under the terms of the plan. The total premiums paid for the plan year ending 06/30/2023 were \$1,087,830.

Because they are so-called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 06/30/2023, the premiums paid under such "experience-rated" contracts were \$31,533 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$25,984.
